

Notice of Second Written Procedure for senior bonds issued by Koggbron Projekt AB (publ)

To the holders of the up to SEK 350,000,000 (or its equivalent in NOK and USD) Senior Secured Callable Fixed Rate Bonds due 2019 with ISIN: NO0010787617 and NO0010787625 (the "Senior Bonds") issued by Koggbron Projekt AB (publ) (the "Issuer") on 24 March 2017.

Capitalized terms not otherwise defined in this notice shall have the meaning given to them in the terms and conditions relating to the Senior Bonds (the "Terms and Conditions").

This notice will be sent by Intertrust (Sweden) AB (the "Trustee") on 6 March 2019 to direct registered owners and registered authorized nominees of the Bonds. This voting request has also been published on the websites of the Issuer and the Trustee, in accordance with the Terms and Conditions. If you are an authorized nominee under the Norwegian Securities Register Act of 2002 no. 64 (NW. Verdipapirregisterloven) or if you otherwise are holding Bonds on behalf of someone else on a Securities Account, please forward this notice to the holder you represent as soon as possible. See "Voting rights" in section B. (Decision procedure) for further information.

On 13 February 2019, the Trustee initiated a written procedure upon the request of the Issuer (the "First Written Procedure"). The First Written Procedure, which ended 12.00 (CET) on 5 March 2019, did not meet the quorum requirement set out in Clause 16(i) of the Terms and Conditions.

The Trustee, acting in its capacity as Trustee for the Bondholders under the Terms and Conditions, hereby initiates a second written procedure (the "**Second Written Procedure**") whereby the Bondholders can approve or reject a proposal from the Trustee to amend and restate the Terms and Conditions and provide certain consents and waivers under the Terms and Conditions. The Request (as defined below) and the background thereto is described in section A. (*Request*) below.

NO DUE DILIGENCE CARRIED OUT IN CONNECTION WITH THIS SECOND WRITTEN PROCEDURE

Please note that no due diligence whatsoever (legal, financial, tax, environment or otherwise) has been carried out for the purposes of the Second Written Procedure or with respect to the Issuer or the Karlholm Strand Project (as defined below), why this notice does not contain any risk factors or other disclosures with respect to the Issuer or the Karlholm Strand Project. There may thus be risks related to the Request set out below which could have a material negative impact on the Bondholders' prospects of recovery under the Senior Bonds and each Bondholder is solely responsible for making its own assessment of the Request before participating in the Second Written Procedure.

LIMITATION OF LIABILITY OF THE TRUSTEE

The proposal set out in this Second Written Procedure is being presented based on the Trustee's best judgement of the current situation without having evaluated all possibilities and factors affecting the situation, the Issuer or its assets/liabilities or the Bondholders. Consequently, no assessment has been made by the Trustee or any of its advisors of the relative merits of accepting the proposal set out herein or the rejection of it. The Trustee can further not guarantee any satisfactory outcome of the proposal set out herein, e.g. that the assets can be sold during the extended tenure of the Senior Bonds or to a satisfactory price or that the sale proceeds can be used to amortize the Senior Bonds within a sufficient time frame. The full responsibility for the sales process will thus remain with the Issuer, however with a new owner. The Trustee assumes no liability whatsoever for any loss arising directly or indirectly from the implementation of the Request (as defined below).

ALL BONDHOLDERS ARE STRONGLY ENCOURAGED TO REVIEW AND CONSIDER THE REQUEST

Before making a decision, each Bondholder is advised to carefully review the content of this document and the proposed resolutions set out in sections 2 and 3 below and the limitation of liability provision set out above. If a Bondholder is uncertain as to the content and significance of this document and the measures the

Bondholder should take, the Bondholder is advised to consult its own legal, tax or financial adviser for this purpose. The Trustee will not, and is under no obligation to, update this document.

INVESTOR PRESENTATION

In connection with this Second Written Procedure , a high-level investor presentation (the "**Investor Presentation**") has been prepared for information purposes only. The Investor Presentation contains more detailed information about the current state of the Karlholm Strand Project, including pictures and videos of the work in progress. Bondholders are encouraged to review the Investor Presentation for a more comprehensive picture of the Karlholm Strand Project.

PARTICIPATION IN THE SECOND WRITTEN PROCEDURE

Bondholders may participate in the Second Written Procedure by completing and sending the voting form attached below to the Trustee. The Trustee must **receive the voting form no later than by 12.00 (CET) on 22 March 2019** by mail, via courier or e-mail to the addresses indicated below. Votes received thereafter will be disregarded. Please note that the Second Written Procedure may expire early if the requisite majority consents of the total Adjusted Nominal Amount have been received before 5 March 2019.

To be eligible to participate in the Second Written Procedure a person must fulfil the formal criteria for being a Bondholder on 6 March 2019 (the "Record Date"). This means that the person must be registered on a Securities Account as a direct registered owner or authorised nominee with respect to one or several Senior Bonds.

If you have an interest in a Senior Bond but are not registered as a direct registered owner or authorised nominee on a Securities Account, you need to obtain a power of attorney or other proof of authorisation from the person who fulfils the formal criteria for being a Bondholder on the Record Date, to be able to participate. An alternative may be to ask the person that is registered as a Bondholder and holds the Senior Bonds on your behalf to vote in its own name as instructed by you. A. Request

1. Background

The Issuer is the owner of (i) the project development company Karlholm Strand AB which owns, through subsidiaries, the main property Tierp Karlholm 1:53 and certain other subdivided properties on which the Karlholm Strand project is contemplated to be developed (the "**Karlholm Strand Project**"), and (ii) through its subsidiary MI Andersson Fastigheter AB, the properties Helsingborg Sanden 4, Helsingborg Sanden 5, Helsingborg Sanden 12, Helsingborg Sanden 13 and Helsingborg Sanden 14 (the "**Sanden Properties**") and Järfälla Skälby 3:533 (the "**Järfälla Property**").

The Issuer has issued two bond loans consisting of (i) the Senior Bonds in the approximate nominal amount of SEK 350,000,000 (or its equivalent in NOK and USD), with a fixed interest rate of 11.50 per cent. *per annum*, and (ii) second lien bonds in the approximate nominal amount of SEK 75,000,000 (or its equivalent in NOK and USD), with a fixed interest rate of 18.00 per cent. *per annum* (the "**Second Lien Bonds**").

The Koggbron group, to which the Issuer belongs, has during the last year undergone severe financial difficulties and have defaulted on several of their debt obligations, including under the Senior Bonds and the Second Lien Bonds. Due to the financial turmoil and lack of liquidity in the Koggbron group, the Issuer has not been able to finalize the Karlholm Strand Project according to the plan presented to the Bondholders in connection with the issuance of the Senior Bonds. As a result, the construction work and initiation of the sales process have been substantially delayed and there are currently no prospects for the current management and owner of the Issuer to complete the Karlholm Strand Project and thereby repay the Bondholders. The status of the properties, on which the Karlholm Strand Project is contemplated to be developed, is currently not in a state allowing them to be sold for a sufficient price and further work need to be carried out by a new owner in order to bring the assets to a marketable form.

In 2018, the Issuer tried to sell the Sanden Properties and the Järfälla Property for the purpose of applying the sale proceeds towards partial amortization of the Senior Bonds. However, the prospective buyer was not able to raise sufficient financing to fund the acquisition of these properties at the time.

The delay of the completion of the Karlholm Strand Project and the failed divestment of the abovementioned properties have affected the Issuer's liquidity and the Issuer has therefore not been able to pay interest due under the Bonds.

The Issuer has therefore concluded that it will not be able to finalise the Karlholm Strand Project according to plan and redeem the Bonds on the original Final Maturity Date.

As the Issuer is in default under the Bonds, the Transaction Security may be enforced. However, a forced enforcement of the Transaction Security would cause a substantial value loss for the Bondholders since the current status of the properties on the Karlholm Strand Project are not yet in a sellable form. Therefore, the Trustee has together with JOOL Markets (the arranger of the Senior Bonds) and the previous owner and entrepreneur behind the Karlholm Strand Project, Anders Högberg (references to "Anders Högberg" shall in this notice also include references to his fully owned companies Mimex Management SA and Dextris Terminus SA (as applicable)), worked to find an alternative solution with the aim of:

- (i) sell the Sanden Properties and the Järfälla Property and use the sale proceeds (after payment of accrued costs of the Trustee and its advisors) to partially amortize the Senior Bonds; and
- (ii) as soon as and as far as possible, completing the Karlholm Strand Project in an efficient manner and commencing the construction work and sales activities and use the net disposal proceeds to service the debt under the Senior Bonds and thereafter the Second Lien Bonds (the Senior Bonds shall be prioritized in relation to the Second Lien Bonds in accordance with the terms and conditions for the Senior Bonds and the Second Lien Bonds, please also see below the proposal regarding the Senior Profit Sharing Interest (as defined below)).

2. Proposal

2.1 Summary of the proposal

In order to facilitate a sale of the Sanden Properties and Järfälla Property and encourage the former owner Anders Högberg to take over the Karlholm Strand Project with an aim to complete the project and repay the Bondholders, the below proposal (the "**Proposal**"), in summary, is being made. Please note that an approval of the Proposal by the Bondholders will be an approval of all items listed below.

In summary, the main terms of the Proposal set out below is thus that Anders Högberg (being the former owner of and the entrepreneur behind the Karlholm Strand Project) shall:

- (i) acquire the shares in the Issuer for SEK 1;
- (ii) replace the Issuer's existing management, with appropriate managers appointed by Anders Högberg;
- (iii) partially finance and complete the Karlholm Strand Project; and
- (iv) use its best efforts to procure that the properties within the Karlholm Strand Project are sold off with an aim to redeem the Senior Bonds and thereafter the Second Lien Bonds in full (please also see the proposal regarding the Senior Profit Sharing Interest (as defined below)).

Furthermore, given that the original time table to complete the Karlholm Strand Project has been considerably delayed and that no properties have yet been sold off resulting in a liquidity deficit in the Issuer, it is also proposed to strengthen the Issuer's financial condition and avoid a mandatory liquidation due to high interest costs (or capitalised interest that would create a deficit in the balance sheet of the Issuer) and grant an extension of the tenure of the Bonds by:

- (i) divesting the Sanden Properties and the Järfälla Property and apply the net disposal proceeds to (A) cover costs incurred by the Trustee (including legal fees) and (B) partially redeem the Senior Bonds;
- (ii) as from 24 March 2018, a "profit sharing interest" (the "**Senior Profit Sharing Interest**") is introduced equivalent to an amount equivalent to an interest rate of 4.00 *per annum* which is accumulated as from 24 March 2018 until the date of full redemption of the Senior Bonds. The Senior Profit Sharing Interest is payable only if there is sufficient surplus cash left in the Issuer after having redeemed the Senior Bonds in full, management fees and development costs have been paid (as described below) and there are no properties left to divest (please note that there will thus not be any cash interest paid during the tenor of the Senior Bonds nor any capitalized interest, but the obligation to pay the Senior Profit Sharing Interest will arise only if there are sufficient surplus cash in the Issuer after the redemption of the Senior Bonds and management fees and development costs have been paid (as described below)); and
- (iii) extending the Final Maturity Date of the Senior Bonds with four years (i.e. to 24 March 2023).

For information purposes, the Second Lien Bonds will have a similar "profit sharing interest" component of 6.00 per annum (the "**Second Lien Profit Sharing Interest**") and will be payable in case there are sufficient funds in the Issuer after (i) the full redemption of the Senior Bonds, (ii) payment of the Senior Profit Sharing Interest and full redemption of the Second Lien Bonds.

Please see below for a full description of the Proposal.

2.2 Change of the management and control of the Issuer

The Issuer is currently managed by its board members, Thomas Melin, Johan Tungard and Michael Sundback, and CEO, Thomas Schelin (the "**Existing Management**"). Furthermore, the shares in the Issuer are currently owned by (i) Koggbro Fastigheter AB (90 per cent.) and (ii) Anders Högberg (through his company Dextris Terminus SA) (10 per cent.)

Anders Högberg is the former owner of and the entrepreneur behind the Karlholm Strand Project and he owns the neighbouring properties in which he has made a considerable investments. Anders Högberg has a proven track-record of developing the neighbouring properties and has a capable organisation with proper equipment and machines as well as a network of sub-contractors to carry out necessary construction work. Anders Högberg is dependent on the Karlholm Strand Project being completed in order to secure the value of the investments he has already made to the neighbouring property.

Please see the separate Investor Presentation, including videos and pictures, of the current state of the project.

In light of the above, it is proposed that:

- (i) the shares in the Issuer held by Koggbron Fastigheter AB are sold for SEK 1 to Anders Högberg (to his fully-owned company Mimex Management SA);
- (ii) the Existing Management of the Issuer is replaced by Anders Högberg and any other appropriate person(s) appointed by him; and
- (iii) Mimex Management SA and/or Dextris Terminus SA pledge all the shares in the Issuer as security for the Issuer's due fulfilment of its obligations under the Bonds and the Second Lien Bonds.

For the avoidance of doubt, the Issuer shall continue to be the debtor under, and issuer of, the Bonds also after Anders Högberg (through Mimex Management SA) has acquired the remaining shares in the Issuer.

Please note that the existing parent company guarantee by Koggbron Fastigheter AB will be maintained with a cap of SEK 33,750,000 and not be released until the Bondholders have been repaid and that such guarantee may be called upon at a later stage.

2.3 Settlement of outstanding debt owed to companies controlled by Anders Högberg and maintenance of a limited parent company guarantee

The Issuer has an outstanding debt and other unsettled compensation payments in the amount of approximately SEK 33,750,000 owed to companies controlled by Anders Högberg for certain work conducted and to be conducted in relation to the Karlholm Strand Project. According to the Terms and Conditions, the Issuer should have used parts of the deposited development funds to pay for parts of these costs. However, it has now been apparent that the Issuer has used such funds for other purposes than paying these costs. To settle the outstanding payments to Anders Högberg, it is proposed that the Issuer shall transfer the properties Tierp Karlholm 1:81, Tierp Karlholm 1:82, Tierp Karlholm 1:83, Tierp Karlholm 1:84, Tierp Karlholm 1:85, Tierp Karlholm 1:86, Tierp Karlholm 1:88 and Tierp Karlholm 1:101 (which are subject to the Transaction Security) (the "**Subdivided Properties**") to companies controlled by Anders Högberg and that the full purchase price shall be paid by way of sett-off against the debt and unpaid compensation owed by the Issuer to Anders Högberg. The current valuation of the Subdivided Properties amount to approximately SEK 33,750,000 according to Anders Högberg. In order to incentivise Anders Högberg to swiftly finalize the demolition work, the transfer of the property Tierp Karlholm 1:84 shall not be made to Högberg until he has procured that the existing boiler house (Sw. *pannhus*) on that property has been demolished. In order to compensate the Bondholders for the exposures set out above, the former owner, Koggbron Fastigheter AB, will maintain its parent company guarantee with a cap of SEK 33,750,000.

2.4 Disposal of the Sanden Properties and the Järfälla Property

In preparation of this Second Written Procedure, the Trustee has requested the current owner of the Issuer to present a plan for the divestment of the Sanden Properties and the Järfälla Property, the sale proceeds to be used for amortizing the Senior Bonds. The following proposal has been set forth:

- (i) the Issuer shall before the change of ownership and take-over by Anders Högberg, sell the Sanden Properties for a purchase price of SEK 75,000,000, where SEK 65,000,000 shall be paid in cash in connection with the sale and SEK 10,000,000 shall remain as a secured loan note which shall be repaid no later than 30 April 2019. The loan note shall be secured with a property mortgage in the Sanden Properties with priority from SEK 65,000,000 to 75,000,000. Should the loan note not be repaid by 30 April 2019, the Issuer shall have the right to re-purchase the Sanden Properties for SEK

65,000,000 or alternatively for SEK 75,000,000 if the Järfälla Property is not sold by 30 August 2019 (as set out below);

- (ii) the former owner of the Issuer, Koggbron Fastigheter AB, has the right to direct a purchaser of the Järfälla Property for SEK 40,000,000. The sale shall be completed no later than 30 August 2019 and shall be made in cash;
- (iii) the sale proceeds from the sale of the Sanden Properties and the Järfälla Property shall be applied to pay accrued costs of the Trustee and its advisors and thereafter to partially amortize the Senior Bonds;
- (iv) should the disposals set out above not be possible to carry out within the time frames set out above, the properties shall remain with the Issuer and new sales may be conducted by the Issuer with the approval of the Trustee (including as to timing, price and format) taking the Bondholders' interest into consideration and with an aim to use net sale proceeds to partially amortize the Senior Bonds.

2.5 Disposal of the Karlholm Strand Project and redemption of the Senior Bonds

The Karlholm Strand Project is currently divided into several land plots on which condominium and rental apartment buildings and villas may be built. When Anders Högberg has assumed ownership of the Issuer, a new assessment of the land plots' capabilities will be made and sales will be carried out to maximize the value of the properties while also ensuring a swift disposal process. The respective land plots will be sold plot by plot or if possible several blocks at the time. In order to (i) ensure that the Bondholders are repaid as far as possible (ii) maintain sufficient liquidity in the Issuer to develop the project and (iii) compensate Anders Högberg for the work carried out, it is proposed that the proceeds from such disposals shall be applied as follows:

- (i) 80 per cent. shall be applied in the following order of priority:
 - a. **first**, in or towards accrued costs of the Trustee and its advisors;
 - b. **secondly**, in or towards payment of the principal amount of the Senior Bonds (until redeemed in full);
 - c. **thirdly**, in or towards payment of the Senior Profit Sharing Interest (until paid in full);
 - d. **fourthly**, in or towards payment of the principal amount of the Second Lien Bonds (until redeemed in full); and
 - e. **fifthly**, in or towards payment of accrued Second Lien Profit Sharing Interest;
- (ii) 10 per cent. to cover project costs in respect to the Karlholm Strand Project (the "**Project Costs**"); and
- (iii) 10 per cent. as a management fee to Mimex Management SA for the work carried out to develop the Karlholm Strand Project.

The Trustee may agree that up to 10 per cent. of the net proceeds from item (i) is instead allocated to pay Project Costs if the Trustee deems it necessary to further cover Project Costs in respect to the Karlholm Strand Project and maintain a sufficient level of liquidity in the Issuer. In addition, in order to avoid repayments of smaller amounts, the Trustee may decide to withhold minor sale proceeds and carry out amortizations when sale proceeds have accumulated to a higher level determined by the Trustee in its sole discretion.

2.6 Maturity extension and Senior Profit Sharing Interest

To reduce the financial burden of the Issuer and avoid a mandatory liquidation do to e.g. accumulated interest costs and thereby increase the chances of completing the Karlholm Strand Project, it is proposed that:

- (i) as from 24 March 2018, a "profit sharing interest" (the "**Senior Profit Sharing Interest**") is introduced equivalent to an amount equivalent to an interest rate of 4.00 *per annum* which is accumulated as from 24 March 2018 until the date of full redemption of the Senior Bonds. The Senior Profit Sharing Interest is payable only if there is sufficient surplus cash left in the Issuer after having redeemed the Senior Bonds in full, management fees and development costs have been paid (as described below) and there are no properties left to divest (please note that there will thus not be any cash interest paid during the tenor of the Senior Bonds nor any capitalized interest, but the obligation to pay the Senior Profit Sharing Interest will arise only if there are sufficient surplus cash in the Issuer after the redemption of the Senior Bonds and management fees and development costs have been paid (as described below)); and
- (ii) the Final Maturity Date for the Bonds is extended by four years (i.e. to 24 March 2023).

For information purposes, the Second Lien Bonds will have a similar "profit sharing interest" component of 6.00 per annum and will be payable in case there are sufficient surplus cash left in the Issuer after (i) the full redemption of the Senior Bonds, (ii) payment of the Senior Profit Sharing Interest and (iii) full redemption of the Second Lien Bonds. The final maturity date for the Second Lien Bonds will be extended with five years.

3. Request

The Trustee and the Issuer hereby kindly asks the Bondholders to:

1. approve and consent to the Proposals set out above;
2. waive any Events of Defaults continuing under the Terms and Conditions;
3. approve and consent to the release of the security granted by Koggbron Fastigheter AB (publ) over its shares in the Issuer, provided that these shares shall be pledged to the Bondholders as security for the Issuer's due fulfilment of its obligations under the Bonds as soon as practically possible following the acquisition described in paragraph 1 of the Proposal;
4. approve to introduce a cap of SEK 33,750,000 on the parent company guarantee issued by Koggbron Fastigheter AB (publ);
5. approve and consent to the release of security over the Subdivided Properties on the terms set out in the Proposal and that such properties are sold to companies owned by Anders Högberg, by way of set-off against the Issuer's debt to companies owned by Anders Högberg;
6. approve and consent to the amendments to the Terms and Conditions, reflecting the Proposals, as set out in the comparison version attached hereto in Appendix 2 (*Amended and Restated Term and Conditions*) showing the proposed amendments;
7. authorize the Trustee to on behalf of the Bondholders execute and enter any documents that may be necessary to enter into in connection with the Request (as defined below) including any consequential amendments to the Terms & Conditions and Intercreditor Agreement to facilitate the Proposals;
8. approve and consent to the release of security over the Sanden and Järfälla Properties on the terms set out in the Proposal and should the properties not be sold in accordance with the Proposal, authorize the Trustee to on behalf of the Bondholders approve any subsequent sale on market terms and to execute any agreement or document that the Trustee deems necessary in connection with such disposals; and
9. authorize the Trustee to, on behalf of the Bondholders, supervise the sale of the properties within the Karlholm Strand Project and in its reasonable opinion approve such sales and security released in connection with such sales and any minor deviations from the Proposals and the amended Terms & Conditions that the Trustee deems necessary in connection with such sales with an aim to bring the project forward and repaying the Bondholders, in each case under the strict condition that the Trustee shall not be liable towards any person for any such decision or supervision, provided that the Trustee act with reasonable care in connection therewith.

The requests set out in paragraph 1-9 above are jointly referred to as the "**Request**".

The execution of the Request is subject to the bondholders under the Second Lien Bonds have given their approval of to the corresponding request made by the Trustee on the date hereof to the holders of the Second Lien Bonds.

4. Consequences of not accepting the Proposal

As mentioned above, the Koggbron group, to which the Issuer belongs, is currently under severe financial pressure and has defaulted on several of their debt obligations, including under the Senior Bonds and the Second Lien Bonds. Due to the financial turmoil and lack of liquidity in the Koggbron group, the Issuer will not be able to finalize the Karlholm Strand Project according to the plan presented to the Bondholders in connection with the issuance of the Senior Bonds. As a result, the construction work and initiation of the sales process have been substantially delayed and there are currently no prospects for the current management and owner of the Issuer to complete the Karlholm Strand Project and thereby repay the Bondholders. The status of the properties, on which the Karlholm Strand Project is contemplated to be developed, is currently not in a state allowing them to be sold for a sufficient price and further work need to be carried out by a new owner in order to bring the assets to a marketable form.

Should the Bondholders not accept the Proposals set out below, it is likely that the Issuer will file for a bankruptcy and hand over the bankruptcy estate to a bankruptcy administrator. A bankruptcy is normally a very time-consuming and costly process and given the current state of the properties in the Karlholm Strand Project, a severe capital impairment is very likely and there are currently no prospects of selling the properties in their current form for a sufficient price. Consequently, a bankruptcy would result in a great capital loss for the Bondholders

B. Decision procedure

The Trustee will determine whether replies received are eligible to participate in the Second Written Procedure, continuously calculate the replies provided in respect of the Request and determine the result of the Second Written Procedure as soon as possible based thereon.

Once a requisite majority of consents of the Adjusted Nominal Amount for which Bondholders reply in the Second Written Procedure have been received by the Trustee, the relevant decision shall be deemed to be adopted, even if the time period for replies in the Second Written Procedure has not yet expired.

Information about the decision taken in the Second Written Procedure will be sent by notice to the Bondholders, published on the websites of the Issuer and the Trustee and published by way of press release by either the Trustee or the Issuer.

Minutes from the Second Written Procedure shall at the request of a Bondholder be sent to it by the Issuer or the Trustee, as applicable.

If the Request is approved by the Second Written Procedure it will be binding on all Bondholders whether they participated in the Second Written Procedure or voted against the Request or not, in accordance with the Terms and Conditions.

Voting rights

Anyone who wishes to participate in the Second Written Procedure must on 6 March 2019 (the "**Record Date**"):

- a. be registered on the Securities Account as a direct registered owner; or
- b. be registered on the Securities Account as authorized nominee,

with respect to one or several Bonds.

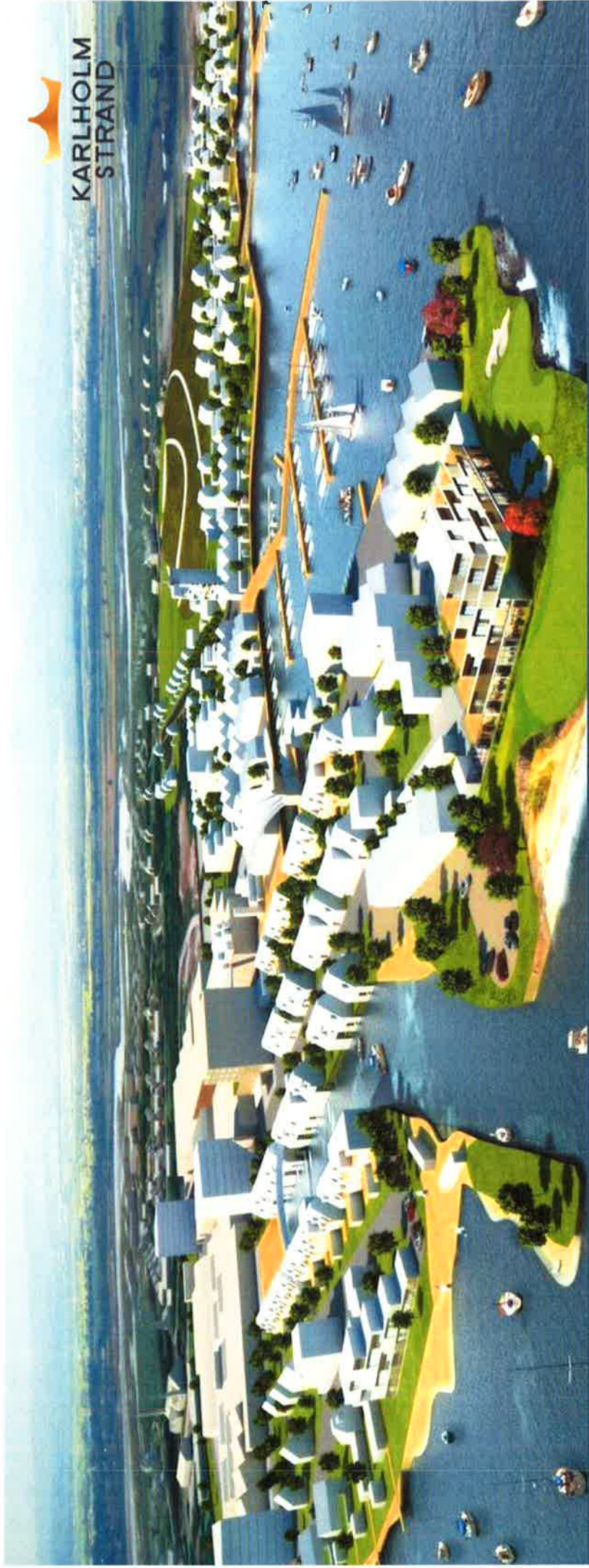

Karlholm Strand

Proposed solution for securing property development, value creation and realization

Summary



Koggbro Projekt AB (publ) (the “**Issuer**” or the “**Company**”) is the owner of the Karlholm Strand project as well as MI Andersson Fastighetsbolag AB, owner of the properties Helsingborg Sanden and Järfälla Skälby. Construction at Karlholm Strand is underway, however due to severe financial difficulties within the Koggbro Group, the Issuer has not been able to carry out the development according to the original plan. As a result, housing units has not been built and sales activities have not been executed as planned.

Anders Högberg, the previous owner of Karlholm Strand AB, intends to repurchase the project and commence construction and sales activities. Anders also owns neighboring properties at Karlholm Strand where development is underway and partly completed. In order to carry out the take over and execute the new plan, a restructuring of the two outstanding bond issues is needed. The aim is to complete the project and repay the bondholders in full.

PLEASE SEE THE NOTICES OF WRITTEN PROCEDURES FOR MORE DETAILED EXPLANATION OF THE PROPOSED TERMS AND CONDITIONS.

Koggbro Projekt AB (publ)'s current outstanding bond issues:

- Senior (first lien) SEK 350m – annual interest of 11,50%
- Junior (second lien) SEK 75m – annual interest of 18,00%

Proposed new bond terms in brief:

- Extend the maturity date with four years, i.e. to 24th march 2023
- Senior (first lien) – annual interest of 4,00% – PIK interest
- Junior (second lien) – annual interest of 6,00% – PIK interest

The new plan in brief:

- Anders Högberg takes over the ownership of the Issuer
- Divest the Sanden and Skälby properties to partially amortize the senior bonds
- Sell plots with building rights to construction contractors, house suppliers etc.
- Start construction of housing units to sell as turn-key accommodation
- Execute sales activities and kick-start with new townhouses



Background



- The Koggbro group, to which the Issuer belongs, is undergoing severe financial difficulties and the group companies have defaulted on a number of their loans.
- The current distressed financial situation has impaired the Karlholm project's liquidity and the Issuer has not been able to make scheduled interest payments.
- As a result the bonds are in default and the Issuer has concluded that it is not able to finalize the project at Karlholm Strand in line with the original plan and thereby repay the bondholders.
- During 2018, the owners of the Issuer where in the process of selling the Helsingborg Sanden and Järfälla Skälby properties in order to facilitate interest payments and amortization of the senior bonds. However, the prospective buyer did not have access to sufficient funding at the time and the transaction was not completed.
- To avoid a forced realization of the project, which would result in significant losses (since the properties at Karlholm are not yet in a sellable form), the bond agent Intertrust have worked together with JOOL Markets and Koggbro to find alternative solutions with the aim to:
 - I. Use sale proceeds from the Helsingborg Sanden and Järfälla Skälby properties to decrease the debt in the Issuer by amortizing on the senior bonds*
 - II. Efficiently realize the Karlholm project, commence construction work and sales activities and use the net disposal proceeds to service the debt under the senior bonds and subsequently the junior bonds*
 - III. The ambition is to repay the full loan amount to the bondholders*



Changes in the structure of the bonds

- Mimex Management SA (a company controlled by Anders Högberg) will acquire the shares in the Issuer for SEK 1.
- The maturity date of the bonds is extended by four years for the senior bonds, i.e. to 24 March 2023, and five years for the junior bonds, i.e. to 24 March 2024.
- Remaining debt after divestment of Helsingborg Sanden and Järfälla Skälby (approx. SEK 350m) will be serviced by divesting Karlholm Strand in stages as plots within the project are sold.
- It is proposed that the proceeds from such sales shall be applied as follows:
 1. 80% shall be applied in the following order of priority:
 - i. first, in or towards accrued costs of the Trustee and its advisors;
 - ii. secondly, in or towards payment of the principal amount of the Senior Bonds (until redeemed in full);
 - iii. thirdly, in or towards payment of the Senior Profit Sharing Interest (until paid in full);
 - iv. fourthly, in or towards payment of the principal amount of the Junior Bonds (until redeemed in full);
 - v. fifthly, in or towards payment of accrued Junior Profit Sharing Interest;
 2. 10% to cover project costs in respect to the Karlholm Strand Project; and
 3. 10% as a management fee to Mimex Management SA for the work carried out to develop the Project.



Changes in the structure of the bonds

- As from 24 March 2018, a "profit sharing interest" is introduced equivalent to an amount equivalent to an interest rate of 6.00 *per annum* on the junior bonds (the "Junior Profit Sharing Interest") and 4.00 per annum on the Senior Bonds (the "Senior Profit Sharing Interest"), which is accumulated as from 24 March 2018 until the date of full redemption of the Senior Bonds and Junior Bonds respectively.
- The Senior Profit Sharing Interest is payable only if there are sufficient surplus cash left in the Issuer after having redeemed the Senior Bonds in full and the management fee and development costs have been paid.
- The Junior Profit Sharing Interest is payable only if there are sufficient surplus cash left in the Issuer after having redeemed the Senior Bonds in full, management fee and development costs have been paid, the Senior Profit Sharing Interest has been paid in full, the Junior Bonds have been redeemed in full and there are no properties left to divest.
- Please note that there will thus not be any cash interest paid during the tenor of the bonds nor any capitalized interest, but the obligation to pay the Senior Profit Sharing Interest and Junior Profit Sharing Interest will arise only if there are sufficient surplus cash in the Issuer after application of the payment priority described above.
- The reason for not applying an "ordinary" capitalized interest, is that the balance sheet of the Issuer likely could not bear capitalized interest over the tenure of the bonds. The profit sharing interest on the other hand only comes into legal existence if there is surplus cash left in the Issuer.



Current project and property status

Ground works

- All filling has been completed according to the building requirements. More than 1 million tons of filling materials have been added to the project
- All seaside building rights are ready for construction
- A small area on the property is currently used for landfill and will be prepared for development as soon as an agreement with the municipality and the County Administrative Board (sw. *Länsstyrelsen*) has been reached on how this should be handled

Environmental clean-up

- Environmental requirements in connection with ground works have been fulfilled according to plan
- Correct handling of deposited landfill masses on site remains to be finalized with the County Administrative Board (Sw. *länsstyrelsen*)
- Until then, such masses will be placed on a separate plot to not affect the progress on the remaining area

Individual plot distribution

- The area consists of multiple plots with individual building rights
- This makes it easier to sell plots to contractors or house suppliers

Roads and infrastructure

- Roads and other infrastructure will be connected to the individual plots when they are sold
- The roads and infrastructure will subsequently be owned by the municipality
- Högberg is in dialogue with the municipality about a gradual overtaking of this infrastructure as it is being completed
- This is expected to significantly reduce the liquidity need in the project

Remaining work

- Complete the demolition of the "Boiler-houses", and the removal of concrete mass from it
- Development of the port facility



Plans going forward

General

- The goal is to initiate construction and begin sales/marketing efforts as soon as possible, in order to raise funds and realize the values-inherent in the project

Property

- The most important measure in order to begin construction activities is to demolish the so-called "Boiler-house" (intended to be carried out in February/March)
- Also of high importance is to construct the first houses and complete the port facility (during spring/summer 2019)
- Ground works for roads and infrastructure is completed. Build-out to individual plots will be gradually done as development and sales process continues

Construction activities

- Selling the first plots often constitute the most challenging phase – As the construction is ongoing and ramped up, attracting more potential buyers will be easier
- To kick off construction activities, Högberg intend to build 9 townhouses on his own plots (i.e. not on the property owned by Koggbron Projekt AB (publ)), so that these can be placed on the market. This is an important milestone and will make it easier to future developers
- Parallell to this, Högberg intend to actively market the Karlholm Strand project to other players (construction contractors, house suppliers) so that several construction projects can be carried out simultaneously and subsequently offered on the market

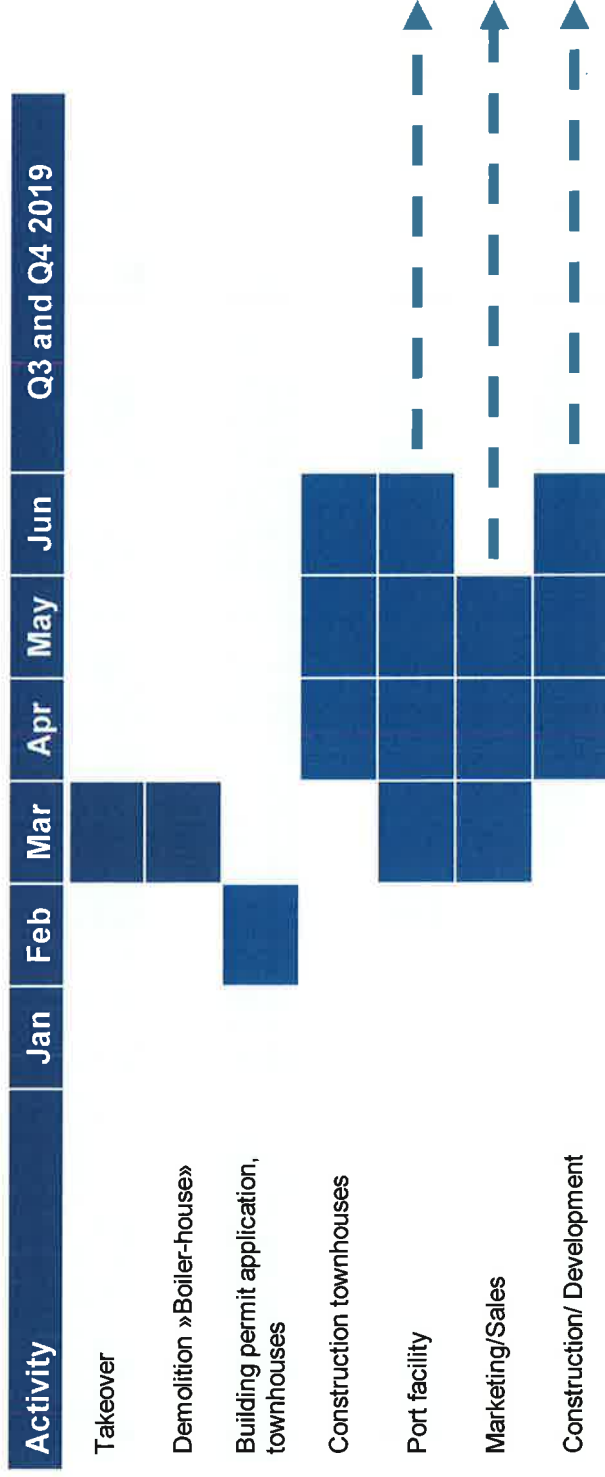
The port facility

- The area is fully prepared all the way to the seaside which enables easy construction
- The plan is to build a seaside port area with service facilities for leisure boating (spring/summer 2019)
- The port facility will be placed in a separate legal entity, and the development costs for the facility will be financed by selling shares in the entity, that simultaneously provides investors with reserved boat parking space. The harbour will be part of the properties taken over by Högberg
- The port facility is of key importance to the attractiveness of the entire project and will be given high priority

Sales strategy

- The fact that the project includes several areas with separate building rights means that these can be marketed and sold to other players such as construction contractors, house suppliers etc
- Increased construction activities in this way, with multiple involved parties, would contribute to higher overall interest in the area
- This model is expected to be effective in order to ensure progress in the development and realization of project value

Anders Högberg



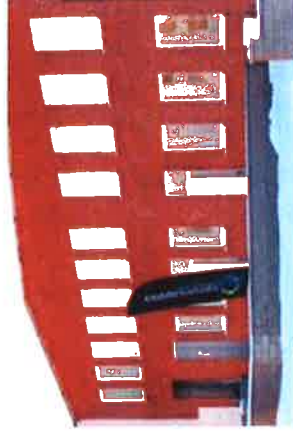
- Anders Högberg is the former owner of and the entrepreneur behind the Karlholm Strand Project.
- Högberg also owns the neighbouring properties in which he has made considerable investments.
- He has completed the plans that were outlined when the sale to Koggbron was completed.
- The renovation work in the industrial area owned by Anders Högberg has come a long way, and several of the buildings have been converted into new facilities such as store premises, restaurant premises, boat garages, fitness area and apartments.



Anders Högberg

The renovation work of Högberg's properties has included:

- 22.000 sqm new roofing
- New industrial doors
- Facade and interior renovation
- New infrastructure such as roads, electricity, water and drainage
- Anders Högberg manages his own organisation with a network of subcontractors and equipment to conduct renovation and ground works
- Högberg has invested significant amounts in the properties and is dependent on completing the project in order to secure the value of investments he has already made
- Most of the ground works are completed but it is important to continue construction of housing, apartments and seaside area to realize the value inherent in the project



Summary of the proposal



- The previous owner of the Karlholm Strand project, Anders Högberg, takes over the shares in Koggbro Projekt AB (publ) for SEK 1 through his fully owned company Mimex Management SA
- The plan is to as soon as possible divest the Sanden Properties and the Järfälla Property and use the sale proceeds (after payment of accrued costs of the Trustee and its advisors) to partially amortize the Senior Bonds
- Following the sale of the shares in Koggbro Projekt AB (publ) to Anders Högberg, he will once again be the owner of the Karlholm Strand project and the remaining debt in Koggbro Projekt AB (publ) after settlement from the divested properties Helsingborg Sanden and Järfälla Skälby will approximately be SEK 350m
- The ground work on the property where Karlholm Strand is to be built and is estimated to be completed and ready for partial development and sale in the spring of 2019
- Högberg has claims on the Issuer in a total amount of approximately SEK 33.5m relating to inter alia unpaid construction costs, which according to the terms and conditions, should have been paid from the deposited development funds, but such funds have been used for other purposes.
- To settle Högberg's claims, Högberg will by way of set-off take over properties from Koggbro Projekt AB (publ) in the area to a corresponding value in relation to the original valuation (constitutes about 10% of the land value)
- In order to compensate the Bondholders for the wrongful use of the development funds, the former owner, Koggbro Fastigheter AB, will maintain its parent company guarantee with a cap of SEK 33,750,000 – (the guarantee will not be released until the Bondholders have been repaid and that such guarantee may be called upon at a later stage)



Summary of the proposal



- The goal is to initiate construction and sales of properties as soon as possible, in order to start repaying the bond debt
- Anders Högberg manages a capable organisation with a network of contractors and equipment and he has made significant investments on the neighbouring properties as well as on the properties he now takes over
- Commencing construction and sales process is central for Högberg in order to secure the values of investments he has already made – he has a significant incentive to succeed
- To address the liquidity needs in the Issuer and the delay in the original time table, there is a need to restructure the bonds both in terms of reduced interest rates, interest capitalization and extended maturity
- Debt repayment will take place in stages as the project is gradually developed and sold
- At the request of Anders Högberg, the process will be monitored by Intertrust to ensure that the bondholders' interests are being safeguarded

Helsingborg Sanden & Järfälla Skälby

- The divestment of the Helsingborg Sanden and Järfälla Skälby properties are expected to generate SEK 115m (SEK 75 m and SEK 40 m respectively)
- Divestment of Helsingborg Sanden is intended to take place prior to Anders Höberg's takeover of Koggbro Projekt AB (publ), for a purchase price of SEK 65m in cash and a secured promissory note of SEK 10m to be settled no later than 30 April 2019
- Divestment of Järfälla Skälby is intended to take place for a purchase price of SEK 40m, no later than 30 August 2019
- In case the promissory note is not settled by 30 April 2019, or Järfälla Skälby is not divested by August 30th 2019, the issuer has the right to repurchase the Helsingborg Sanden property at the same price
- The successful sale of Helsingborg Sanden and Järfälla Skälby cannot be guaranteed and in case a sale cannot be carried out, the properties will remain within the bonds' security structure and subsequent attempts at disposal will be made at a later stage.
- The proceeds from this sale will be used to repay part of the principal of the senior bonds, and costs accrued by the trustee and its advisors. Once these costs have been covered and the senior bonds have been redeemed in full Senior Profit Sharing Interest will be paid. After this the payment of the junior bonds will commence including Junior Profit Sharing Interest will commence.

1. Definitions and Construction

1.1 Definitions

In these terms and conditions (the "**Terms and Conditions**"):

"**Account Operator**" means (i) in relation to the SEK Bonds a bank or other party duly authorised to operate as an account operator pursuant to the Swedish Financial Instruments Accounts Act and (ii) in relation to the NOK Bonds and USD Bonds a bank or other party registered as account operator (No. *Kontofører*) with VPS, through which a Bondholder has opened a Securities Account in respect of its Bonds.

"**Adjusted Nominal Amount**" means the Total Nominal Amount less the Nominal Amount of all Bonds owned by a Group Company or an Affiliate, irrespective of whether such person is directly registered as owner of such Bonds.

"**Advance Purchase Agreements**" means (a) an advance or deferred purchase agreement if the agreement is in respect of the supply of assets or services and payment is due not more than 90 days after the date of supply, or (b) any other trade credit incurred in the ordinary course of business.

"**Affiliate**" means any Person, directly or indirectly, controlling or controlled by or under direct or indirect common control with such specified Person. For the purpose of this definition, "**control**" when used with respect to any Person means the power to direct the management and policies of such Person, directly or indirectly, whether through the ownership of voting securities, by contract or otherwise; and the terms "**controlling**" and "**controlled**" have meanings correlative to the foregoing.

"**Arranger**" means JOOL Markets AS, Bryggegata 14, 0250 Oslo, Norway.

"**Blocked Account**" means a bank account in the name of the Issuer held with a reputable Swedish bank, which shall be pledged on a first priority basis in favour of the Trustee, representing the Bondholders, on which ~~(i) SEK 54,000,000 shall be deposited for the purpose of interest payments, (ii) any Permitted Disposal Proceeds is deposited which may either be used for interest payments or deposited awaiting a mandatory prepayment of the Bonds and (iii) the Development Funds are deposited~~any net disposal proceeds received by the Group from any permitted disposal made pursuant to Clauses 9.4 (Permitted Karlholm Disposals) and 9.5 (Permitted MI Andersson Disposals), shall be deposited pending partial redemption of the Bonds.

"**Bondholder**" means a person who is registered on a Securities Account as direct registered owner or nominee with respect to a Bond.

"**Bondholders' Meeting**" means a meeting among the Bondholders held in accordance with Clause ~~17~~18 (*Bondholders' Meeting*).

"**Bond**" means a SEK Bond and/or a NOK Bond and/or a USD Bond.

"**Business Day**" means a Business Day Sweden and a Business Day Norway.

"**Business Day Norway**" means a day other than a Saturday, Sunday or a public holiday in Norway on which the Norwegian Central Bank's and the CSD's settlement systems are open and commercial banks in Norway are open for business.

"**Business Day Sweden**" means a day in Sweden other than a Sunday or other public holiday and on which day the CSD settlement system is open. Saturdays, Midsummer Eve (Sw. *midsommarafton*), Christmas Eve (Sw. *julafton*) and New Year's Eve (Sw. *nyårsafton*) shall for the purpose of this definition be deemed to be public holidays.

"**Change of Control Event**" means the occurrence of an event or series of events whereby the ~~Guarantor~~Parents, directly or indirectly, jointly ceases to control (a) ~~90~~100% of the shares or votes of the Issuer, or (b) the right to, directly or indirectly, appoint or remove the whole or a majority of the directors of the board of directors of the Issuer.

"**CSD**" means the Issuer's central securities depository and registrar in respect of the Bonds, initially (i) in respect of SEK Bonds Euroclear Sweden AB, Swedish Reg. No. 556112-8074, P.O. Box 191, 101 23 Stockholm, Sweden and (ii) in respect of the NOK Bonds and USD Bonds, Verdipapirsentralen ASA (org. nr. 985 140 421, Fred Olsens gate 1, 0152 Oslo) ("**VPS**"), or another party replacing it, as CSD, in accordance with these Terms and Conditions.

"**CSD Regulations**" means the relevant CSD's rules and regulations applicable to the Issuer, the Trustee and the Bonds from time to time.

"**Downstream Loans**" means any future loans from the Issuer to its subsidiaries from time to time, including, but not limited to, the Karlholm Loan and the MI Andersson Loan.

 - (iv) a provision of law is a reference to that provision as amended or re-enacted; and
 - (v) a time of day is a reference to Stockholm time.

The Issuer undertakes to make payments in relation to the Bonds and to comply with these Terms and Conditions.

- (b) By subscribing for Bonds, each initial Bondholder agrees that the Bonds shall benefit from and be subject to the Finance Documents and by acquiring Bonds, each subsequent Bondholder confirms such agreement.
- (c) The Nominal Amount of each SEK Bond is SEK 10,000, for each NOK Bond NOK 10,000 and for each USD Bond USD 1,000 (the "**Nominal Amount**"). The maximum Total Nominal Amount of the Bonds is SEK 350,000,000 (or its equivalent in NOK or USD). All ~~initial~~ Bonds are issued on a fully paid basis at an issue price of 100 per cent. of the Nominal Amount.
- (d) The minimum permissible investment amount upon issuance of the Bonds is SEK 1,000,000, NOK 1,000,000 and USD 150,000 respectively.
- (e) The Bonds constitute direct, general, unconditional, unsubordinated and secured obligations of the Issuer and shall at all times rank *pari passu* with (i) the Junior Bonds pursuant to the terms of the Intercreditor Agreement, provided however that the Junior Bonds will receive proceeds from the enforcement of the Transaction Security and certain disposals only after any obligations under the Bonds have been repaid in full (including payment of Senior Profit Sharing Interest (if any)), and (ii) all direct, unconditional, unsubordinated and unsecured obligations of the Issuer, except those obligations which are mandatorily preferred by law, and without any preference among them.

~~(the "Nomus Loan") and repay a loan borrowed from Nomus Fastighets AB for which the Sanden Properties have been pledged to certain creditors in order to release the security over the Sanden Properties. The Issuer shall ensure that as soon as reasonably practicable after the Issue Date, each such creditor is repaid and any security over held by such creditor over the Sanden Properties is released and thereafter pledged to the Bondholders represented by the Security Agent. Pending such repayment, the relevant funds shall be held in escrow by the Arranger.~~

5. ~~(b) Should any such security not be possible to release within a reasonable period of time, the relevant security may be maintained and the relevant funds marked to repay a relevant creditor/pledgee shall be deposited on the Blocked Account and be used towards interest payments and/or partial redemption of the Bonds in connection with a prepayment of Permitted Disposal Proceeds.~~

Transfer Restrictions

- (a) Bondholders may be subject to purchase or transfer restrictions with regard to the Bonds, as applicable from time to time under local laws to which a Bondholder may be subject (due to e.g. its nationality, its qualification, its residency, its registered address or its place(s) for business). No party other than the Bondholder shall be responsible to ensure compliance with such laws and regulations and each Bondholder must ensure compliance with local laws and regulations applicable at their own cost and expense.
- (b) No action is being taken in any jurisdiction that would or is intended to permit a public offering of the Bonds or the possession, circulation or distribution of any document or other material relating to the Issuer or the Bonds in any jurisdiction, where action for that purpose is required. Each Bondholder must inform itself about, and observe, any applicable restrictions to the transfer of material relating to the Issuer or the Bonds.

6. Bonds in Book-Entry Form

- (a) The Bonds will be registered for the Bondholders on their respective Securities Accounts and no physical notes will be issued. The SEK Bonds will be registered in accordance with the Swedish Financial Instruments Accounts Act and the NOK Bonds and USD Bonds will be registered in accordance with the Norwegian Securities Register Act and the terms and conditions of the VPS. Registration requests relating to the Bonds shall be directed to an Account Operator.
- (b) The Issuer shall at all times ensure that the registration of the Bonds in the CSD is correct.

- (a) If any person, other than a Bondholder, wishes to exercise any rights under the Finance Documents, it must obtain a power of attorney or other proof of authorisation from the Bondholder or a successive, coherent chain of powers of attorney or proofs of authorisation starting with the Bondholder and authorising such person.
- (b) A Bondholder may issue one or several powers of attorney to third parties to represent it in relation to some or all of the Bonds held by it. Any such representative may act independently under the Finance Documents in relation to the Bonds for which such representative is entitled to represent the Bondholder and may further delegate its right to represent the Bondholder by way of a further power of attorney.

9. Transaction Security

- (a) As continuing Security for the due and punctual fulfilment of the Secured Obligations, the Issuer and the Guarantor grant on the Issue Date the Transaction Security and the Guarantee to the Secured Parties as represented by the Trustee on the terms set out in the Security Documents and the Guarantee Agreement and subject to the ranking set out in the Intercreditor Agreement.
- (b) The Trustee shall hold the Transaction Security and the Guarantee on behalf of the Secured Parties in accordance with the Security Documents and the Intercreditor Agreement. The Issuer shall enter into the Security Documents and the Guarantee Agreement and ~~subject to Clause 4.4 (Delayed MI Andersson Security)~~ perfect the Transaction Security in accordance with the Security Documents on or about the Issue Date.
- (c) Unless and until the Trustee has received instructions from the Bondholders in accordance with Clause ~~16-17~~ 16-17 (*Decisions by Bondholders*), the Trustee shall (without first having to obtain the Bondholders' consent) be entitled to enter into agreements with the Issuer or a third party or take any other actions, if it is, in the Trustee's opinion, necessary for the purpose of maintaining, altering, releasing or enforcing the Transaction Security, creating further Security for the benefit of the Secured Parties or for the purpose of settling the Bondholders' or the Issuer's rights to the Transaction Security, in each case in accordance with the terms of the Finance Documents, and provided that such agreements or actions are not detrimental to the interests of the Bondholders.
- (d) The Security Agent shall be entitled to give instructions relating to the Transaction Security and the Guarantee to the Security Agent in accordance with the Intercreditor Agreement.

9.2 Release of Security and Guarantee

The Security Agent may at any time, acting on instructions of the Trustee (acting on behalf of the Bondholders), release Transaction Security and the Guarantee in accordance with the terms of the Security Documents, the Guarantee Agreement and the Intercreditor Agreement. For the avoidance of doubt any Transaction Security or Guarantee will always be released *pro rata* between the Bondholders and Junior Bondholders and the remaining Transaction Security will continue to rank *pari passu* between the Bondholders and the Junior Bondholders as set forth in the Security Documents, the Guarantee Agreement and the Intercreditor Agreement.

9.3 Enforcement of Security and Guarantee

- (a) The ~~Trustee~~ Security Agent may only take any action to accelerate or enforce any Transaction Security or Guarantee in accordance with the terms of the Intercreditor Agreement, which contains various provisions relating to

amongst other things enforcement of the Transaction Security and the Guarantee.

The Issuer and its Subsidiaries have the right to dispose of any subdivided properties within the Karlholm Properties, including partnerships or companies owning such properties, by requesting a release of the security over that specific property and/or company from the Security Agent, provided that the assets are sold on arm length's terms at the prevailing market value and the net disposal proceeds are applied in the following order:

- (a) 80 per cent. shall be applied in the following order of priority:
 - (i) first, in or towards accrued costs of the Trustee, the Security Agent and their advisors;
 - (ii) secondly, in or towards redemption of the principal amount of the Bonds (until redeemed in full);

- (c) The sale proceeds from the sale of the Sanden Properties and the Järfälla Skälby Property shall be applied to pay accrued costs of the Trustee and its advisors and thereafter to partially redeem the Bonds.
- (d) Should the disposals set out above not be possible to carry out within the time frames set out above, the properties shall remain with the Issuer and new sales may be conducted by the Issuer on market terms and with the approval of the Trustee (including as to timing, price and format). The Issuer shall not (i) pay any dividend on its shares, (ii) repurchase any of its own shares, (iii) redeem its share capital or other restricted equity with repayment to shareholders, (iv) make any repayments on loans to the direct or indirect shareholder of the Issuer, or any Affiliates of the Issuer or its shareholders, or (v) make any other similar distribution or transfers of value to the direct or indirect shareholder of the Issuer, or any Affiliates of the Issuer, other than payment of management fees in accordance with Clause 9.4(c).

14.3 ~~13.3~~ Nature of Business

The Issuer shall procure that no substantial change is made to the general nature of the business carried on by the Issuer as of the Issue Date if such change is reasonably likely to have a Material Adverse Effect.

14.4 ~~13.4~~ Financial Indebtedness

The Issuer shall not (and shall ensure that neither of its subsidiaries) incur any additional Financial Indebtedness, provided however that the Issuer may incur Financial Indebtedness that constitute Permitted Debt.

14.5 ~~13.5~~ Disposal of Assets

The Issuer shall not (and shall ensure that neither of its subsidiaries) sell or otherwise dispose of all or substantially all of its assets or operations to any person, other than [any permitted disposals made pursuant to Clauses 9.4 \(Permitted *Karlholm* Disposals\) and 9.5 \(Permitted *MI Andersson* Disposals\)](#).

14.6 ~~13.6~~ Negative Pledge

The Issuer shall not (and shall ensure that neither of its subsidiaries) provide, prolong or renew any guarantee or security over any of its assets (present or future), provided however that the Issuer has a right to provide, prolong and renew any Permitted Security.

14.7 ~~13.7~~ Financial Support

The Issuer shall not (and shall ensure that neither of its subsidiaries) provide any loan or security or guarantee to or for the benefit of any party, other than the Nomus Loan ~~and~~ the Permitted Debt [and secured vendor loans in connection with the disposal of the Sanden Properties or the Järfälla Skälby Property](#).

14.8 ~~13.8~~ Dealings with Related Parties

The Issuer shall (and shall ensure that its subsidiaries) conduct all dealings with the direct and indirect shareholders of the Issuer and/or any Affiliates of such direct and indirect shareholders at arm's length terms.

14.9 ~~13.9~~ Environmental compliance and claims

- (a) The Issuer shall and shall procure that its Subsidiaries will:
- (i) comply with all Environmental Laws, including in relation to human health and conditions on workplace;
 - (ii) obtain, maintain and ensure compliance with all requisite Environmental Permits; and

- (iii) implement procedures to monitor compliance with and to prevent liability under any Environmental Law, in each case where failure to do so has or is reasonably likely to have a Material Adverse Effect.
- (b) The Issuer shall, promptly upon becoming aware of the same, inform the Trustee of any claim, proceeding or investigation in respect of any such Environmental Law against any member of the Group which is current, pending or threatened where which, if determined against that member of the Group, has or is reasonably likely to have a Material Adverse Effect.

15. ~~14.~~ Events of Default and Acceleration of the Bonds

Each of the events or circumstances set out in this Clause ~~14-~~15 (other than Clause ~~14~~5.10 (*Acceleration of the Bonds*)) is an Event of Default.

15.1 ~~14.1~~ Non-Payment

The Issuer fails to pay an amount on the date it is due in accordance with the Finance Documents, unless its failure to pay is caused by administrative or technical error and payment is made within five (5) Business Days of the due date.

15.2 ~~14.2~~ Other Obligations

The Issuer does not comply with its obligations under the Finance Documents, in any other way than as set out under Clause ~~14~~5.1 above, unless the non-compliance (i) is capable of remedy and (ii) is remedied within fifteen (15) Business Days of the earlier of the Trustee giving notice and the Issuer becoming aware of the non-compliance.

15.3 ~~14.3~~ Cross-default

- (a) Any financial indebtedness of the Group or the Guarantor is not paid when due nor within any originally applicable grace period.
- (b) Any financial indebtedness of the Group or the Guarantor is declared to be or otherwise becomes due and payable prior to its specified maturity as a result of an event of default (however described).
- (c) Any commitment for any financial indebtedness of the Group or the Guarantor is cancelled or suspended by a creditor of the Issuer or the Property Company as a result of an event of default (however described).
- (d) Any creditor of the Group or the Guarantor becomes entitled to declare any financial indebtedness of the Group or the Guarantor due and payable prior to its specified maturity as a result of an event of default (however described).
- (e) No Event of Default will occur under this Clause ~~14~~5.3 if the aggregate amount of financial indebtedness or commitment for financial indebtedness falling within paragraphs (a) to (d) above is less than SEK 5,000,000 (or its equivalent in any other currency or currencies).

15.4 ~~14.4~~ Insolvency

- (a) Any member of the Group or the Guarantor is unable or admits inability to pay its debts as they fall due or is declared to be unable to pay its debts under applicable law, suspends making payments on its debts generally or, by reason of actual or anticipated financial difficulties, commences negotiations with its creditors with a view to rescheduling its Financial Indebtedness; or
- (b) a moratorium is declared in respect of the Financial Indebtedness of any Group Company or the Guarantor.

15.5 ~~14.5~~ Insolvency Proceedings

Any corporate action, legal proceedings or other procedures are taken (other than proceedings or petitions which are being disputed in good faith and are discharged, stayed or dismissed within 30 Business Days of commencement or, if earlier, the date on which it is advertised) in relation to:

- (a) the suspension of payments, winding-up, dissolution, administration or reorganisation (by way of voluntary agreement, scheme of arrangement or otherwise) of any of any Group Company or the Guarantor; and
- (b) the appointment of a liquidator, receiver, administrator, administrative receiver, compulsory manager or other similar officer in respect of any Group Company or the Guarantor or any of its assets or any analogous procedure or step is taken in any jurisdiction.

15.6 ~~14.6~~ Mergers and Demergers

A decision is made that any Group Company shall be demerged or merged if such merger or demerger is likely to have a Material Adverse Effect, provided that a merger involving the Issuer, where the Issuer is not the surviving entity, shall always be considered an Event of Default and provided that the Issuer may not be demerged.

15.7 ~~14.7~~ Creditors' Process

Any expropriation, attachment, sequestration, distress or execution or any analogous process in any jurisdiction affects any asset or assets of any Group Company or the Guarantor, having an aggregate value of an amount equal to or exceeding SEK 5,000,000 and is not discharged within 30 days.

15.8 ~~14.8~~ Impossibility or Illegality

It is or becomes impossible or unlawful for the Issuer to fulfil or perform any of the provisions of the Finance Documents or if the obligations under the Finance Documents are not, or cease to be, legal, valid, binding and enforceable.

15.9 ~~14.9~~ Continuation of the Business

Any of the Issuer or the Guarantor ceases to carry on its business or in the case of a merger or a demerger as stipulated in Clause ~~14.5~~.6 above.

15.10 ~~14.10~~ Acceleration of the Bonds

- (a) If an Event of Default has occurred and is continuing, the Trustee is entitled to, on behalf of the Bondholders (i) by notice to the Issuer, declare all, but not some only, of the Bonds due for payment together with any other amounts payable under the Finance Documents, immediately or at such later date as the Trustee determines (but such date may not fall after the Final Maturity Date), and (ii) exercise any or all of its rights, remedies, powers and discretions under the Finance Documents.
- (b) The Trustee may not accelerate the Bonds in accordance with Clause ~~14.5~~.10(a) by reference to a specific Event of Default if it is no longer continuing or if it has been decided, on a Bondholders' Meeting or by way of a Written Procedure, to waive such Event of Default (temporarily or permanently).
- (c) The Trustee shall notify the Bondholders of an Event of Default within five (5) Business Days of the date on which the Trustee received actual knowledge of that an Event of Default has occurred and is continuing. The Trustee shall, within twenty (20) Business Days of the date on which the Trustee received actual knowledge of that an Event of Default has occurred and is continuing, decide if the Bonds shall be accelerated. If the Trustee decides not to accelerate the Bonds, the Trustee shall promptly seek instructions from the Bondholders in accordance with Clause ~~16-17~~ (*Decisions by Bondholders*). The Trustee shall always be entitled to take the time necessary to consider whether an occurred event constitutes an Event of Default.
- (d) If the Bondholders (in accordance with these Terms and Conditions) instruct the Trustee to accelerate the Bonds, the Trustee shall, provided that the provisions of the Intercreditor Agreement have been complied with, promptly declare the Bonds due and payable and take such actions as, in the opinion of the Trustee, may be necessary or desirable to enforce the rights of the Bondholders under the Finance Documents, unless the relevant Event of Default is no longer continuing.
- (e) If the right to accelerate the Bonds is based upon a decision of a court of law, an arbitral tribunal or a government authority, it is not necessary that the decision has become enforceable under law or that the period of appeal has expired in order for cause of acceleration to be deemed to exist.
- (f) In the event of an acceleration of the Bonds in accordance with this Clause ~~14.5~~.10, the Issuer shall redeem all Bonds with an amount equal to the ~~redemption amount specified in Clause 11.3 (Voluntary Total Redemption (call option)), as applicable considering when the acceleration occurs~~ 101 per cent of the Nominal Amount.

16. ~~15.~~ Distribution of Proceeds

(a) Subject to Clause 11 (*Application of Recoveries*) under the Intercreditor Agreement, all payments by the Issuer relating to the Bonds and the Finance Documents following an acceleration of the Bonds in accordance with Clause ~~14–15~~ (*Events of Default and Acceleration of the Bonds*) and any proceeds received from an enforcement of the Transaction Security shall be applied in the following order of priority, in accordance with the instructions of the Trustee:

(i) *first*, in or towards payment pro rata of (i) all unpaid fees, costs, expenses and indemnities payable by the Issuer to the Trustee in accordance with the Trustee Agreement (other than any indemnity given for liability against the Bondholders), (ii) other costs, expenses and indemnities relating to the acceleration of the Bonds or the protection of the Bondholders' rights as may have been incurred by the Trustee, (iii) any costs incurred by the Trustee for external experts that have not been reimbursed by the Issuer in accordance with Clause ~~20~~1.2(e), and (iv) any costs and expenses incurred by the Trustee in relation to a Bondholders' Meeting or a Written Procedure that have not been reimbursed by the Issuer in accordance with Clause ~~16~~7(c); together with default interest in accordance with Clause ~~10(d)11~~ (*Default Interest*) on any such amount calculated from the date it was due to be paid or reimbursed by the Issuer;

~~(ii) *secondly*, in or towards payment pro rata of accrued but unpaid Interest under the Bonds;~~

~~(iii)~~ ~~*thirdly*~~, secondly, in or towards payment pro rata of any unpaid principal under the Bonds; ~~and~~

thirdly, in or towards payment pro rata of accrued but unpaid Junior Profit Sharing Interest under the Bonds (if any); and

(iv) *fourthly*, in or towards payment pro rata of any other costs or outstanding amounts unpaid under the Finance Documents, including default interest in accordance with Clause ~~10(d)11~~ (*Default Interest*) on delayed payments ~~of Interest and repayments~~ of principal under the Bonds.

Any excess funds after the application of proceeds in accordance with paragraphs (i) to (iv) above shall be paid to the Issuer.

(b) Funds that a Bondholder receives (directly or indirectly) in connection with the acceleration of the Bonds or the enforcement of the Transaction Security shall constitute escrow funds (*Sw. redovisningsmedel*) and must be promptly turned over to the Trustee to be applied in accordance with this Clause ~~15–16~~ as soon as reasonably practicable.

17. ~~16.~~ Decisions by Bondholders

- (a) Any decision by the Bondholders on a matter relating to the Finance Documents shall (at the option of the Trustee) be dealt with at a Bondholders' Meeting or by way of a Written Procedure.
- (b) Any request from the Issuer or a Bondholder (or Bondholders) representing at least ten (10) per cent. of the Adjusted Nominal Amount (such request may only be validly made by a person who is a Bondholder on the Business Day immediately following the day on which the request is received by the Trustee and shall, if made by several Bondholders, be made by them jointly) for a decision by the Bondholders on a matter relating to the Finance Documents shall be directed to the Trustee and dealt with at a Bondholders' Meeting or by way of a Written Procedure, as determined by the Trustee. The person requesting the decision may suggest the form for decision making, but if it is in the Trustee's opinion more appropriate that a matter is dealt with at a Bondholders' Meeting than by way of a Written Procedure, it shall be dealt with at a Bondholders' Meeting.
- (c) The Trustee may refrain from convening a Bondholders' Meeting or instigating a Written Procedure if (i) the suggested decision must be approved by any person in addition to the Bondholders and such person has informed the Trustee that an approval will not be given, or (ii) the suggested decision is not in accordance with applicable laws.
- (d) Should the Trustee not convene a Bondholders' Meeting or instigate a Written Procedure in accordance with these Terms and Conditions, without Clause ~~167~~(c) being applicable, the Issuer or the Bondholder(s) requesting a decision by the Bondholders may convene such Bondholders' Meeting or instigate such Written Procedure, as the case may be, instead.
- (e) Should the Issuer want to replace the Trustee, it may (i) convene a Bondholders' Meeting in accordance with Clause ~~178~~(a) or (ii) instigate a Written Procedure by sending communication in accordance with Clause ~~189~~(a), in both cases with a copy to the Trustee. After a request from the Bondholders pursuant to Clause ~~201.4~~(c), the Issuer shall no later than ten (10) Business Days after receipt of such request (or such later date as may be necessary for technical or administrative reasons) convene a Bondholders Meeting in accordance with Clause ~~178~~(a). The Issuer shall inform the Trustee before a notice for a Bondholders' Meeting or communication relating to a Written Procedure where the Trustee is proposed to be replaced is sent and shall, on the request of the Trustee, append information from the Trustee together with the a notice or the communication.
- (f) Only a person who is, or who has been provided with a power of attorney pursuant to Clause 7 (*Right to Act on Behalf of a Bondholder*) from a person who is, registered as a Bondholder:
 - (i) on the Business Day specified in the notice pursuant to Clause ~~178~~(b) of the Bondholders' Meeting, or

- (ii) on the Business Day specified in the communication pursuant to Clause ~~18~~9(b), in respect of a Written Procedure,

may exercise voting rights as a Bondholder at such Bondholders' Meeting or in such Written Procedure, provided that the relevant Bonds are included in the definition of Adjusted Nominal Amount. Such Business Day specified pursuant to paragraph (i) or (ii) above must fall no earlier than one (1) Business Day after the effective date of the notice or communication, as the case may be.

- (g) Subject to the terms of the Intercreditor Agreement, the following matters shall require the consent of Bondholders representing at least sixty-six and two thirds (66 2/3) per cent. of the Adjusted Nominal Amount for which Bondholders are voting at a Bondholders' Meeting or for which Bondholders reply in a Written Procedure in accordance with the instructions given pursuant to Clause ~~18~~9(b):

- (i) a change to the terms of any of Clauses 2(a), 2(e) and 5(b);
- (ii) a change to the terms for the distribution of proceeds set out in Clause ~~15-16~~16 (*Distribution of Proceeds*);
- (iii) a change to the terms dealing with the requirements for Bondholders' consent set out in this Clause ~~16~~7;

~~(iv) a change to the definition "Interest Rate" set out in Clause 1.1 (Definitions);~~

~~(v)~~ (iv) a release of the Transaction Security, except in accordance with the terms of the Security Documents;

~~(vi)~~ (v) a change of Issuer, an extension of the tenor of the Bonds or any delay of the due date for payment of any principal or interest on the Bonds;

~~(vii)~~ (vi) a mandatory exchange of the Bonds for other securities; and

~~(viii)~~ (vii) early redemption of the Bonds, other than upon an acceleration of the Bonds pursuant to Clause ~~14-15~~15 (*Events of Default and Acceleration of the Bonds*) or as otherwise permitted or required by these Terms and Conditions.

- (h) Any matter not covered by Clause ~~16~~7(g) shall require the consent of Bondholders representing more than fifty (50) per cent. of the Adjusted Nominal Amount for which Bondholders are voting at a Bondholders' Meeting or for which Bondholders reply in a Written Procedure in accordance with the instructions given pursuant to Clause ~~18~~9(b). This includes, but is not limited to, any amendment to, or waiver of, the terms of any Finance Document that does not require a higher majority (other than an amendment permitted pursuant to Clause ~~19(a)(i)~~20(a)(i) or ~~19(a)(ii)~~20(a)(ii)) or an acceleration of the Bonds or the enforcement of any Transaction Security.

- (i) Quorum at a Bondholders' Meeting or in respect of a Written Procedure only exists if a Bondholder (or Bondholders) representing at least fifty (50) per cent. of the Adjusted Nominal Amount in case of a matter pursuant to Clause 167(g), and otherwise twenty (20) per cent. of the Adjusted Nominal Amount:
- (i) if at a Bondholders' Meeting, attend the meeting in person or by telephone conference (or appear through duly authorised representatives); or
 - (ii) if in respect of a Written Procedure, reply to the request.

If a quorum exists for some but not all of the matters to be dealt with at a Bondholders' Meeting or by a Written Procedure, decisions may be taken in the matters for which a quorum exists.

- (j) If a quorum does not exist at a Bondholders' Meeting or in respect of a Written Procedure, the Trustee or the Issuer shall convene a second Bondholders' Meeting (in accordance with Clause 178(a)) or initiate a second Written Procedure (in accordance with Clause 189(a)), as the case may be, provided that the person(s) who initiated the procedure for Bondholders' consent has confirmed that the relevant proposal is not withdrawn. For the purposes of a second Bondholders' Meeting or second Written Procedure pursuant to this Clause 167(j), the date of request of the second Bondholders' Meeting pursuant to Clause 178(a) or second Written Procedure pursuant to Clause 189(a), as the case may be, shall be deemed to be the relevant date when the quorum did not exist. The quorum requirement in Clause 167(i) shall not apply to such second Bondholders' Meeting or Written Procedure.
- (k) Any decision which extends or increases the obligations of the Issuer or the Trustee, or limits, reduces or extinguishes the rights or benefits of the Issuer or the Trustee, under the Finance Documents shall be subject to the Issuer's or the Trustee's consent, as applicable.
- (l) A Bondholder holding more than one Bond need not use all its votes or cast all the votes to which it is entitled in the same way and may in its discretion use or cast some of its votes only.
- (m) The Issuer may not, directly or indirectly, pay or cause to be paid any consideration to or for the benefit of any Bondholder for or as inducement to any consent under these Terms and Conditions, unless such consideration is offered to all Bondholders that consent at the relevant Bondholders' Meeting or in a Written Procedure within the time period stipulated for the consideration to be payable or the time period for replies in the Written Procedure, as the case may be.
- (n) A matter decided at a duly convened and held Bondholders' Meeting or by way of Written Procedure is binding on all Bondholders, irrespective of them being present or represented at the Bondholders' Meeting or responding in the Written Procedure. The Bondholders that have not adopted or voted for a

decision shall not be liable for any damages that this may cause other Bondholders.

- (o) All reasonable costs and expenses incurred by the Issuer or the Trustee for the purpose of convening a Bondholders' Meeting or for the purpose of carrying out a Written Procedure, including reasonable fees to the Trustee, shall be paid by the Issuer.
- (p) If a decision is to be taken by the Bondholders on a matter relating to the Finance Documents, the Issuer shall promptly at the request of the Trustee provide the Trustee with a certificate specifying the number of Bonds (and the relevant denomination of such Bonds) owned by Group Companies, irrespective of whether such person is directly registered as owner of such Bonds. The Trustee shall not be responsible for the accuracy of such certificate or otherwise be responsible for determining whether a Bond is owned by a Group Company.
- (q) Information about decisions taken at a Bondholders' Meeting or by way of a Written Procedure shall promptly be sent by notice to the Bondholders and be published on the websites of the Issuer and the Trustee, provided that a failure to do so shall not invalidate any decision made or voting result achieved. The minutes from the relevant Bondholders' Meeting or Written Procedure shall at the request of a Bondholder be sent to it by the Issuer or the Trustee, as applicable.

18. ~~17.~~ Bondholders' Meeting

- (a) The Trustee shall convene a Bondholders' Meeting as soon as practicable and in any event no later than ten (10) Business Days after receipt of a valid request from the Issuer or the Bondholder(s) (or such later date as may be necessary for technical or administrative reasons) by sending a notice thereof to each person who is registered as a Bondholder on a date selected by the Trustee which falls no more than five (5) Business Days prior to the date on which the notice is sent.
- (b) The notice pursuant to Clause ~~17.8~~(a) shall include (i) time for the meeting, (ii) place for the meeting, (iii) agenda for the meeting (including each request for a decision by the Bondholders), (iv) the day on which a person must be a Bondholder in order to exercise Bondholders' rights at the Bondholders' Meeting, and (v) a form of power of attorney. Only matters that have been included in the notice may be resolved upon at the Bondholders' Meeting. Should prior notification by the Bondholders be required in order to attend the Bondholders' Meeting, such requirement shall be included in the notice.
- (c) The Bondholders' Meeting shall be held no earlier than ten (10) Business Days and no later than thirty (30) Business Days after the effective date of the notice.
- (d) Without amending or varying these Terms and Conditions, the Trustee may prescribe such further regulations regarding the convening and holding of a

Bondholders' Meeting as the Trustee may deem appropriate. Such regulations may include a possibility for Bondholders to vote without attending the meeting in person.

19. ~~18.~~ Written Procedure

- (a) The Trustee shall instigate a Written Procedure as soon as practicable and in any event no later than ten (10) Business Days after receipt of a valid request from the Issuer or the Bondholder(s) (or such later date as may be necessary for technical or administrative reasons) by sending a communication to each person who is registered as a Bondholder on a date selected by the Trustee which falls no more than five (5) Business Days prior to the date on which the communication is sent.
- (b) A communication pursuant to Clause ~~189~~(a) shall include (i) each request for a decision by the Bondholders, (ii) a description of the reasons for each request, (iii) a specification of the Business Day on which a person must be registered as a Bondholder in order to be entitled to exercise voting rights, (iv) instructions and directions on where to receive a form for replying to the request (such form to include an option to vote yes or no for each request) as well as a form of power of attorney, and (v) the stipulated time period within which the Bondholder must reply to the request (such time period to last at least ten (10) Business Days and not longer than thirty (30) Business Days from the effective date of the communication pursuant to Clause ~~189~~(a)). If the voting is to be made electronically, instructions for such voting shall be included in the communication.
- (c) When consents from Bondholders representing the requisite majority of the total Adjusted Nominal Amount pursuant to Clauses ~~167~~(g)- and ~~167~~(h) have been received in a Written Procedure, the relevant decision shall be deemed to be adopted pursuant to Clause ~~167~~(g) or ~~167~~(h), as the case may be, even if the time period for replies in the Written Procedure has not yet expired.

20. ~~19.~~ Amendments and Waivers

- (a) Subject to the terms of the Intercreditor Agreement, the Issuer and the Trustee (acting on behalf of the Bondholders) may agree to amend the Finance Documents or waive any provision in a Finance Document, provided that:
 - (i) such amendment or waiver is not detrimental to the interest of the Bondholders, or is made solely for the purpose of rectifying obvious errors and mistakes;
 - (ii) such amendment or waiver is required by applicable law, a court ruling or a decision by a relevant authority; or
 - (iii) such amendment or waiver has been duly approved by the Bondholders in accordance with Clause ~~16—17~~ (*Decisions by Bondholders*).

- (b) The Trustee shall promptly notify the Bondholders of any amendments or waivers made in accordance with Clause ~~19(a)~~20(a), setting out the date from which the amendment or waiver will be effective, and ensure that any amendments to the Finance Documents are published in the manner stipulated in Clause ~~123.3~~ *(Information among the Bondholders)*. The Issuer shall ensure that any amendments to the Finance Documents are duly registered with the CSD and each other relevant organisation or authority (to the extent such registration is possible in accordance with the rules of the CSD).
- (c) An amendment to the Finance Documents shall take effect on the date determined by the Bondholders Meeting, in the Written Procedure or by the Trustee, as the case may be.

21.1 ~~20.1~~ Appointment of the Trustee

- (a) By subscribing for Bonds, each initial Bondholder appoints:
 - (i) the Trustee to act as its Trustee in all matters relating to the Bonds and the Finance Documents, and authorises the Trustee to act on its behalf (without first having to obtain its consent, unless such consent is specifically required by these Terms and Conditions) in any legal or arbitration proceedings relating to the Bonds held by such Bondholder, including the winding-up, dissolution, liquidation, company reorganisation (Sw. *företagsrekonstruktion*) or bankruptcy (Sw. *konkurs*) (or its equivalent in any other jurisdiction) of the Issuer including any legal or arbitration proceeding relating to the perfection, preservation, protection or enforcement of the Transaction Security; and
 - (ii) confirms the appointment under the Intercreditor Agreement of the Security Agent to act as its agent in all matters relating to the Transaction Security, the Security Documents, the Guarantee and the Guarantee Agreement, including any legal or arbitration proceeding relating to the perfection, preservation, protection or enforcement of the Transaction Security and the Guarantee and acknowledges and agrees that the rights, obligations, role of and limitations of liability for the Security Agent is further regulated in the Intercreditor Agreement.
- (b) By acquiring Bonds, each subsequent Bondholder confirms the appointment and authorisation for the Trustee to act on its behalf, as set out in Clause ~~20~~21.1(a).
- (c) Each Bondholder shall immediately upon request provide the Trustee with any such documents, including a written power of attorney (in form and substance satisfactory to the Trustee), that the Trustee deems necessary for the purpose of exercising its rights and/or carrying out its duties under the Finance

Documents. The Trustee is under no obligation to represent a Bondholder which does not comply with such request.

- (d) The Issuer shall promptly upon request provide the Trustee with any documents and other assistance (in form and substance satisfactory to the Trustee), that the Trustee deems necessary for the purpose of exercising its rights and/or carrying out its duties under the Finance Documents.
- (e) The Trustee is entitled to fees for its work and to be indemnified for costs, losses and liabilities on the terms set out in the Finance Documents and the Trustee Agreement and the Trustee's obligations as Trustee under the Finance Documents are conditioned upon the due payment of such fees and indemnifications.
- (f) The Trustee may act as Trustee or trustee for several issues of securities issued by or relating to the Issuer and other Group Companies notwithstanding potential conflicts of interest.

21.2 ~~20.2~~ Duties of the Trustee

- (a) The Trustee shall represent the Bondholders in accordance with the Finance Documents, and, where relevant, in relation to instructions to the Trustee to enforce the Transaction Security on behalf of the Bondholders. Except as specified in Clauses 4 (*Conditions Precedent for Disbursement*), the Trustee is not responsible for the execution or enforceability of the Finance Documents.
- (b) When acting in accordance with the Finance Documents, the Trustee is always acting with binding effect on behalf of the Bondholders. The Trustee shall carry out its duties under the Finance Documents in a reasonable, proficient and professional manner, with reasonable care and skill.
- (c) The Trustee is entitled to delegate its duties to other professional parties, but the Trustee shall remain liable for the actions of such parties under the Finance Documents.
- (d) The Trustee shall treat all Bondholders equally and, when acting pursuant to the Finance Documents, act with regard only to the interests of the Bondholders and shall not be required to have regard to the interests or to act upon or comply with any direction or request of any other person, other than as explicitly stated in the Finance Documents.
- (e) The Trustee is entitled to engage external experts when carrying out its duties under the Finance Documents. The Issuer shall on demand by the Trustee pay all reasonable costs for external experts engaged after the occurrence of an Event of Default, or for the purpose of investigating or considering (i) an event which the Trustee reasonably believes is or may lead to an Event of Default or (ii) a matter relating to the Issuer which the Trustee reasonably believes may be detrimental to the interests of the Bondholders under the Finance Documents. Any compensation for damages or other recoveries received by the Trustee from external experts engaged by it for the purpose of carrying out

its duties under the Finance Documents shall be distributed in accordance with Clause ~~15~~16 (*Distribution of Proceeds*).

- (f) The Trustee shall, as applicable, enter into agreements with the CSD, and comply with such agreement and the CSD Regulations applicable to the Trustee, as may be necessary in order for the Trustee to carry out its duties under the Finance Documents.
- (g) Notwithstanding any other provision of the Finance Documents to the contrary, the Trustee is not obliged to do or omit to do anything if it would or might in its reasonable opinion constitute a breach of any law or regulation.
- (h) If in the Trustee's reasonable opinion the cost, loss or liability which it may incur (including reasonable fees to the Trustee) in complying with instructions of the Bondholders, or taking any action at its own initiative, will not be covered by the Issuer, the Trustee may refrain from acting in accordance with such instructions, or taking such action, until it has received such indemnities (or adequate Security has been provided therefore) as it may reasonably require.
- (i) The Trustee shall give a notice to the Bondholders (i) before it ceases to perform its obligations under the Finance Documents by reason of the non-payment by the Issuer of any fee or indemnity due to the Trustee under the Finance Documents or (ii) if it refrains from acting for any reason described in Clause ~~20~~1.2(h).

21.3 ~~20.3~~ Limited liability for the Trustee

- (a) The Trustee will not be liable to the Bondholders for damage or loss caused by any action taken or omitted by it under or in connection with any Finance Document, unless directly caused by its negligence or wilful misconduct. The Trustee shall never be responsible for indirect loss.
- (b) The Trustee shall not be considered to have acted negligently if it has acted in accordance with advice from or opinions of reputable external experts engaged by the Trustee or if the Trustee has acted with reasonable care in a situation when the Trustee considers that it is detrimental to the interests of the Bondholders to delay the action in order to first obtain instructions from the Bondholders.
- (c) The Trustee shall not be liable for any delay (or any related consequences) in crediting an account with an amount required pursuant to the Finance Documents to be paid by the Trustee to the Bondholders, provided that the Trustee has taken all necessary steps as soon as reasonably practicable to comply with the regulations or operating procedures of any recognised clearing or settlement system used by the Trustee for that purpose.
- (d) The Trustee shall have no liability to the Bondholders for damage caused by the Trustee acting in accordance with instructions of the Bondholders given in

accordance with Clause ~~16–17~~ (*Decisions by Bondholders*) or a demand by Bondholders given pursuant to Clause 145.10.

- (e) Any liability towards the Issuer which is incurred by the Trustee in acting under, or in relation to, the Finance Documents shall not be subject to set-off against the obligations of the Issuer to the Bondholders under the Finance Documents.

21.4 ~~20.4~~ Replacement of the Trustee

- (a) Subject to Clause ~~20.1~~.4(f), the Trustee may resign by giving notice to the Issuer and the Bondholders, in which case the Bondholders shall appoint a successor Trustee at a Bondholders' Meeting convened by the retiring Trustee or by way of Written Procedure initiated by the retiring Trustee.
- (b) Subject to Clause ~~20.1~~.4(f), if the Trustee is Insolvent, the Trustee shall be deemed to resign as Trustee with immediate effect and the Issuer shall within ten (10) Business Days appoint a successor Trustee which shall be an independent financial institution or other reputable company which regularly acts as Trustee under debt issuances.
- (c) A Bondholder (or Bondholders) representing at least ten (10) per cent. of the Adjusted Nominal Amount may, by notice to the Issuer (such notice may only be validly given by a person who is a Bondholder on the Business Day immediately following the day on which the notice is received by the Issuer and shall, if given by several Bondholders, be given by them jointly), require that a Bondholders' Meeting is held for the purpose of dismissing the Trustee and appointing a new Trustee. The Issuer may, at a Bondholders' Meeting convened by it or by way of Written Procedure initiated by it, propose to the Bondholders that the Trustee be dismissed and a new Trustee appointed.
- (d) If the Bondholders have not appointed a successor Trustee within ninety (90) days after (i) the earlier of the notice of resignation was given or the resignation otherwise took place or (ii) the Trustee was dismissed through a decision by the Bondholders, the Issuer shall appoint a successor Trustee which shall be an independent financial institution or other reputable company which regularly acts as Trustee under debt issuances.
- (e) The retiring Trustee shall, at its own cost, make available to the successor Trustee such documents and records and provide such assistance as the successor Trustee may reasonably request for the purposes of performing its functions as Trustee under the Finance Documents.
- (f) The Trustee's resignation or dismissal shall only take effect upon the appointment of a successor Trustee and acceptance by such successor Trustee of such appointment and the execution of all necessary documentation to effectively substitute the retiring Trustee.
- (g) Upon the appointment of a successor, the retiring Trustee shall be discharged from any further obligation in respect of the Finance Documents but shall

remain entitled to the benefit of the Finance Documents and remain liable under the Finance Documents in respect of any action which it took or failed to take whilst acting as Trustee. Its successor, the Issuer and each of the Bondholders shall have the same rights and obligations amongst themselves under the Finance Documents as they would have had if such successor had been the original Trustee.

- (h) In the event that there is a change of the Trustee in accordance with this Clause ~~20~~1.4, the Issuer shall execute such documents and take such actions as the new Trustee may reasonably require for the purpose of vesting in such new Trustee the rights, powers and obligation of the Trustee and releasing the retiring Trustee from its further obligations under the Finance Documents. Unless the Issuer and the new Trustee agree otherwise, the new Trustee shall be entitled to the same fees and the same indemnities as the retiring Trustee.

22. ~~21.~~ Appointment and Replacement of the Paying Agent

- (a) The Issuer appoints the Paying Agent to manage certain specified tasks under these Terms and Conditions and in accordance with the legislation, rules and regulations applicable to and/or issued by the CSD and relating to the Bonds.
- (b) The Paying Agent may retire from its assignment or be dismissed by the Issuer, provided that the Issuer has approved that a commercial bank or securities institution approved by the CSD accedes as new Paying Agent at the same time as the old Paying Agent retires or is dismissed. If the Paying Agent is Insolvent, the Issuer shall immediately appoint a new Paying Agent, which shall replace the old Paying Agent as paying agent in accordance with these Terms and Conditions.

23. ~~22.~~ Appointment and Replacement of the CSD

- (a) The Issuer has appointed the CSD to manage certain tasks under these Terms and Conditions and in accordance with the CSD Regulations and the other regulations applicable to the Bonds.
- (b) The CSD may retire from its assignment or be dismissed by the Issuer, provided that the Issuer has effectively appointed a replacement CSD that accedes as CSD at the same time as the old CSD retires or is dismissed and provided also that the replacement does not have a negative effect on any Bondholder. The replacing CSD must be authorised to professionally conduct clearing operations and be authorised as a central securities depository in accordance with applicable law.

24. ~~23.~~ No Direct Actions by Bondholders

- (a) A Bondholder may not take any steps whatsoever against the Issuer or with respect to the Transaction Security to enforce or recover any amount due or owing to it pursuant to the Finance Documents, or to initiate, support or procure the winding-up, dissolution, liquidation, company reorganisation (*Sw. företagsrekonstruktion*) or bankruptcy (*Sw. konkurs*) (or its equivalent in

any other jurisdiction) of the Issuer in relation to any of the obligations and liabilities of the Issuer under the Finance Documents. Such steps may only be taken by the Trustee.

- (b) Paragraph (a) above shall not apply if:
- (i) the Trustee has been instructed by the Bondholders in accordance with the Finance Documents to take certain actions but fails for any reason to take, or is unable to take (for any reason other than a failure by a Bondholder to provide documents in accordance with Clause ~~20~~1.1(c)), such actions within a reasonable period of time and such failure or inability is continuing. However, if the failure to take certain actions is caused by the non-payment by the Issuer of any fee or indemnity due to the Trustee under the Finance Documents or by any reason described in Clause ~~20~~1.2(h), such failure must continue for at least forty (40) Business Days after notice pursuant to Clause ~~20~~1.2(i) before a Bondholder may take any action referred to in paragraph (a) above; or
 - (ii) the Security Agent has been instructed by the Instructing Party (as defined in the Intercreditor Agreement) in accordance with the Intercreditor Agreement to enforce the Transaction Security and/or Guarantee but is legally unable to take such enforcement actions.

25. ~~24.~~ Prescription

- (a) The right to receive repayment of the principal of the Bonds shall be prescribed and become void ten (10) years from the Redemption Date. The right to receive payment of ~~interest (excluding any capitalised interest)~~ Senior Profit Sharing Interest shall be prescribed and become void three (3) years from the relevant due date for payment. The Issuer is entitled to any funds set aside for payments in respect of which the Bondholders' right to receive payment has been prescribed and has become void.
- (b) If a limitation period is duly interrupted in accordance with the Swedish Act on Limitations (*Sw. preskriptionslag (1981:130)*), a new limitation period of ten (10) years with respect to the right to receive repayment of the principal of the Bonds, and of three (3) years with respect to receive payment of ~~interest (excluding capitalised Senior Profit Sharing Interest)~~ will commence, in both cases calculated from the date of interruption of the limitation period, as such date is determined pursuant to the provisions of the Swedish Act on Limitations.

(b) Any notice or other communication made by one person to another under or in connection with the Finance Documents shall be sent by way of courier, personal delivery (or, in terms of notice or other communication to the Bondholders, delivered through the CSD as set out in (a)(iii) above) or letter and will only be effective, in case of courier or personal delivery, when it has been left at the address specified in Clause 23.1(a) or, in case of letter, three (3) Business Days after being deposited postage prepaid in an envelope addressed to the address specified in Clause 23.1(a) or in case of notice or other communication posted through the CSD, on the date of the message being issued by the CSD.

(c) Any notice pursuant to the Finance Documents shall be in English.

(d) If an Event of Default is continuing, any notice or other communication made by the Trustee to the Issuer under or in connection with the Finance Documents may, provided that the Trustee deems it necessary in order to preserve the Bondholders' rights under the Finance Documents, be sent by email and will be effective on the day of dispatch (unless a delivery failure message was received by the Trustee), save that any notice or other communication sent by email that is sent after 5.00 pm in the place of receipt shall be deemed only to become effective on the following day. Any notice or other communication to be sent by email by the Trustee to the Issuer in accordance with this paragraph (c) shall be sent to the CFO or the CEO of the Issuer, to the email addresses most recently notified by the Issuer to the Trustee.

- (a) Any notice that the Issuer or the Trustee shall send to the Bondholders pursuant to Clauses ~~11.3 (Voluntary total redemption (call option)), 11.4-12.3 (Mandatory repurchase due to a Change of Control Event (put option)), 123.1(a), 123.1(b), 145.10(c), 167(q), 178(a), 189(a) and 19(b)20(b)~~ shall also be published by way of press release by the Issuer or the Trustee, as applicable.
- (b) In addition to Paragraph (a) above, if any information relating to the Bonds or the Group contained in a notice the Trustee may send to the Bondholders under these Terms and Conditions has not already been made public by way of a press release, the Trustee shall before it sends such information to the Bondholders give the Issuer the opportunity to issue a press release containing such information. If the Issuer does not promptly issue a press release and the Trustee considers it necessary to issue a press release containing such information before it can lawfully send a notice containing such information to the Bondholders, the Trustee shall be entitled to issue such press release.

27. ~~26.~~ Force Majeure and Limitation of Liability

- (a) Neither the Trustee nor the Paying Agent shall be held responsible for any damage arising out of any legal enactment, or any measure taken by a public authority, or war, strike, lockout, boycott, blockade, natural disaster, insurrection, civil commotion, terrorism or any other similar circumstance (a "Force Majeure Event"). The reservation in respect of strikes, lockouts, boycotts and blockades applies even if the Trustee or the Paying Agent itself takes such measures, or is subject to such measures.
- (b) The Paying Agent shall have no liability to the Bondholders if it has observed reasonable care. The Paying Agent shall never be responsible for indirect damage with exception of gross negligence and wilful misconduct.
- (c) Should a Force Majeure Event arise which prevents the Trustee or the Paying Agent from taking any action required to comply with these Terms and Conditions, such action may be postponed until the obstacle has been removed.
- (d) The provisions in this Clause ~~25~~6.2 apply unless they are inconsistent with the provisions of the Financial Instruments Accounts Act which provisions shall take precedence.

28. ~~27.~~ Governing Law and Jurisdiction

- (a) These Terms and Conditions, and any non-contractual obligations arising out of or in connection therewith, shall be governed by and construed in accordance with the laws of Sweden.
- (b) The Issuer submits to the non-exclusive jurisdiction of the City Court of Stockholm (Sw. *Stockholms tingsrätt*).

- (c) Paragraphs (a) and (b) above shall not limit the right of the Trustee (or the Bondholders, as applicable) to take proceedings against the Issuer in any court which may otherwise exercise jurisdiction over the Issuer or any of its assets.
- (d) Notwithstanding the above, the NOK Bonds and the USD Bonds shall be registered pursuant to the Norwegian Securities Register Act.
