### **General requirements for all documents:**

- 2" top margin on page 1. All other margins, including top margin on subsequent pages, to be 1".
- Only letter-sized documents accepted at 300 DPI
- Recording hours are Monday, Tuesday, Thursday, and Friday, 8:00 a.m. 4:00 p.m., Wednesday, 8:00 a.m. to 12:00 p.m. (cut-off time, documents can be submitted any time)
