General requirements for all documents:

- 3 inch top margin required on first page; for all other pages, margins to be a minimum of 1.5 in on top and 1 inch sides and bottom
- Minimum 10-point font required
- Only letter-sized documents accepted at 200 DPI
- No Deeds will be eRecorded at this time
- Recording hours are M-F, 8 a.m. to 4 p.m. (cut-off time, documents can be submitted any time)
