General requirements for all documents:

- 2" top and bottom margins required on first and last pages, all other margins on all pages to be ½"
- Letter and Legal sized documents accepted
- Minimum 10 pt font required
- 300 DPI accepted for documents.
- Recording hours are 8:30 AM to 3:00 PM (Cut Off Times, can be submitted any time)
- Conveyance documents cannot be eRecorded at this time
