## General requirements for all documents:

- 2.50 inch top margin required on first page; all other pages, margins to be a minimum of .50 in
- Minimum 10-point font required.
- Only legal/ letter-sized documents accepted at 300 DPI
- Recording hours are M-F, 9 a.m. to 3 p.m. (cut-off time, documents can be submitted any time)
