General requirements for all documents:

- 2.5 inch top margin required on first page; for all other pages, margins to be a minimum of .5 inch on sides and 2.5 on bottom of last page
- Minimum 10-point font required
- Only letter-sized documents accepted at 300 DPI
- Recording hours are M-F, 8:30 a.m. to 4 p.m. (cut-off time, documents can be submitted any time)
