General requirements for all documents:

- 2" top margin on page 1. All other margins, including top margin on subsequent pages, to be 1".
- Only letter-sized documents accepted at 300 DPI
- Recording hours are M-W, F, 8 a.m. to 4 p.m., Thurs 8 a.m. to 5:30 p.m. (cut-off time, documents can be submitted any time)
