**General Requirements for all documents:**

- Both Letter and Legal sized documents accepted, but \$9 non-standard fee charged for Legal
- Min 12 pt font
- 300 DPI accepted for documents.
- eRecording hours are 8:00 AM to 3:00 PM. Documents can be submitted anytime, but will be held if submitted outside of those hours until 8:00 AM on the next business day.
