**General Requirements for all documents:**

- 3" top margin required at top of first page. 1.5" top margin required on all subsequent pages
- All other margins should be 1"
- Letter and Legal sized documents accepted
- Minimum 10 pt font required
- 300 DPI accepted for documents.
- Recorder business hours are 8:00 AM to 4:00 PM
